Maintenance Supervisor Report

- > Took daily readings of the pump house and lift stations.
- > Weed trimming was done in various parts of the village.
- > The lagoon was mowed twice this month.
- Cut a tree down at the lagoon that was hanging over the roadway.
- Richard and I replaced and concreted the post that holds the free library box at city hall and put it back up.
- Alley next to the body shop was blocked off and closed. A new post was concreted into the ground by Richard and I.
- > Weekly mowing was kept up by Richard and I.
- > Diesel fuel was sprayed on manhole covers so the oil and chips would not stick to them.
- Blades were taken off, sharpened, and replaced on the brush hog mower by Richard and I.
- > TV's from behind the maintenance building are being disposed of weekly. (Two a week)
- > Maintenance truck was cleaned out and washed.
- > Dump truck was worked on at TJ's Truck Service and washed by me.
- > Called Blick and Blick to eliminate the fuel tank down at the maintenance shed. It has not been picked up yet though.
- > Dirt was put down on the south east corner of Molly's yard, then seeded.
- > Doors and locks were replaced by Tom Whittington at the maintenance building.
- > Water leak was 31 fixed at the south east apartments coming into town.
- > Richard gives me a hand on most tasks, and is extremely helpful.
- > Water meters started getting read today. (09/27/21)
